## Revenue at ₹ 53.7 Crs and PBT ₹ 8.2 Crs in Q2

**Coimbatore, 21**st **October 2020:** The Board of Directors of Shanthi Gears Limited (SGL) a subsidiary of Tube Investments of India Limited (TII), met today and approved the financial results for the quarter and six months ended 30<sup>th</sup> September, 2020.

## **Highlights**

The Company continues to focus on 4 key priorities of Revenue growth, Profitability, ROCE and Free Cash Flow (FCF).

- Revenue of ₹ 53.7 Crores in the quarter with a 24% degrowth over Q2 of previous year.
- The Profit before tax for the quarter was at ₹ 8.2 Crores as against ₹ 11.9 Crores in Q2 of previous year.
- Focus on cost optimisation and lower capital employed enabled to sustain the Return on average Capital Employed (ROCE) to 19% during Q2.
- The Company generated operating free cash flow of ₹ 9.8 Crores during Q2 and Free cash flow to PAT is 148 % in Q2

During the quarter the Company booked orders for ₹ 76 Crores (against ₹ 61 Crores for corresponding quarter of the previous year). Pending orderbook as on 30<sup>th</sup> September 2020 was ₹ 187 Crores against ₹ 145 Crores in the previous year.
