## Sub: Partial/Small disruption of Operations due to Second Wave of Covid-19 -Intimation under Reg. 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015

We write to inform that in view of the widespread resurgence of the COVID -19 virus resulting in a serious pandemic situation, the Government of Tamil Nadu has enforced a total lockdown in the State from today (10<sup>th</sup> May, 2021) to 24<sup>th</sup> May, 2021. Consequent thereto, we inform that there is a partial/small disruption in our factories due to shortage of manpower and supply of Raw Materials during the aforesaid period. The duration of the disruption of our factories will be for two weeks as can be foreseen at present and a resumption would depend on an improvement in the situation in the State and lifting of the lockdown.

Considering the seriousness of the pandemic situation, the Company is taking various measures to ensure the health and safety of its employees and to comply with the directives regularly being issued by the Central and the State Government besides the local authorities. We further inform that the Company is monitoring the situation for taking timely action based on the guidance from the Governments and the authorities.
